Terms of Competition

1. Upon entering this tournament, I declare that I am eligible under the conditions of the Championship and declare that I am an amateur in accordance with status rules of the Royal and Ancient Golf Club of St Andrews. I declare that I have read and understood the conditions of the tournament.
2. Entries must be on the prescribed form or via email with required details, and ENTRY FEE MUST BE PAID AT TIME OF ENTRY. Entries close with the Secretary of North West Golf Tas., 16 Locket Street, Ulverstone 7315 at 8:00 pm Monday 10th February 2025. Phone entries may be accepted if payment is made via EFT to account listed above.
3. Entries received after this deadline MAY be accepted if the size of the field permits, but if accepted will incur a penalty of \$10.00.
4. The events are open to male amateurs as defined by the Amateur Status Rules of the Royal and Ancient Golf Club of St Andrews, who are members of clubs affiliated with Golf Australia.
5. Male players under the age of 18 years as at the last day of the competition are eligible for the Junior Championship.
6. Male players aged 18 – 23 inclusive as at the last day of the competition are eligible for the Colts (Under 24) Championship.
7. Male players who are aged **50** years or over as on the first day of the event are eligible for the Seniors 36 Hole Championship.
8. The rules of golf and the local rules of the Host Club shall be the rules of play during the Championship.
9. The NWGT Championship Committee reserves the right to make any alterations to the starting times and programme and to refuse any entry without assigning a reason.
10. All disputes and protests must be lodged with the Committee not later than 15 minutes after the end of play on the day in which the disputed matter has arisen and the decision of the NWGT Championship Committee on all points shall be final.
11. All references to handicap to be taken as at first day of competition.
12. Competitors must report to the starter 15 minutes before their appointed hit off time.
13. Draw and Starting Times: A draw for each day's play will be made and published. Players shall start at the time and in the order arranged by the Committee. Rule 5.3.a provides "The player shall start at the time laid down by the Committee". The penalty for breach of rule 5.3.a is disqualification. However, it is a condition of this Championship that, as provided by rule 5.3.a (exception 1), if a player arrives at their starting point ready to play within 5 minutes of their starting time, the penalty for failure to start on time is 2 strokes instead of disqualification.
14. All events shall be under control of the NWGT Championship Committee which will have full power to alter or make any variation to the conditions or alter the indicated starting time of the Event. NWGT may, in the event of bad weather, or for any other reason, fix another day or venue for any contest.
15. In the event of a player failing to hand in a card after each round and satisfactorily explaining the omission to the Championship Committee, that player shall be disqualified from all events in the Championship.
16. Pace of Play: Rule 5.6 will be strictly enforced. Each group must maintain its position on the course with respect to the group preceding it. Any group with a clear hole in front of it will be considered out of position. Penalties will be issued to individuals in such groups who by their pace contribute to such delay. Warnings may not be issued prior to penalties.
17. Host Club's dress regulations must be observed at all times.
18. Ties in the Championships shall be decided by a "sudden death" play-off over such holes as the NWGT Championship Committee determines. Ties in all other events to be decided by count-back in accordance with the approved system.
19. A competitor shall not knowingly make use of any drug to enhance her performance. Any competitor infringing the condition by refusing to take a test may be disqualified.
20. Distance only measuring devices are permitted. Mobile phones must be turned to silent mode.
21. Motorised Transport - During play, it is prohibited for a player to ride in or on a motorised vehicle unless permission has been granted by the Events Committee. Note i: Permission will only be granted to entrants who can provide a Medical Certificate (see Note ii). Note ii: Any player aged 65 years or over is permitted to use motorised transportation without needing to apply to NWGT for approval. However, players should advise NWGT in this circumstance. Note iii: NWGT takes no responsibility for the availability of golf carts.
Penalty for breach of Local Rule: The player gets the general penalty for each hole during which there is a breach of this Local Rule. If the breach occurs between the play of two holes, it applies to the next hole.
22. Competitors and their caddies should abstain from consuming alcohol on the course during the Championship.
